# Chelsea Area Historical Society - 2017

## Membership Levels

**Individual Membership**-Individual shall be a person over the age of 18. Individual Members shall have one (1) vote, may hold office, and may serve on committees.

**Senior**-Senior membership shall be available to any person over the age of 60. Senior Members shall have one (1) vote, may hold office, and serve on committees.

**Junior**-Members shall be any person between the ages of 12 to 18. Junior members may serve on committees. Shall not vote. Shall pay annual dues.

**Patron**-Patron members shall be any person providing support to CAHS. Patron members shall have one (1) vote, may hold office, and may serve on committees.

**Business Membership**-Business membership shall be issued in the name of the business entity. The owner of the business shall have one (1) vote at any meeting of the membership. May serve on the Board of Directors, shall not serve as an officer. Dues will be established by the Board. Membership entitles the business to complimentary advertisements in the newsletter and on the website with Board approval.

**Honorary**-Honorary membership shall be extended by vote of the Board to any person, group, or firm for extraordinary support or service to CAHS. Honorary members shall not pay dues, shall not vote, shall not hold office, and shall not serve on committees. The Board shall determine the duration of the Honorary Membership which shall be for at least one (1) year.
